# Marriott Bonvoy Super Bowl Sleepover Sweepstakes Official Rules

### **HOW IT WORKS:**

- Visit MarriottBonvoyKeysakes.com/NFL and submit the Online Registration Form to earn your first entry.
- Upload photos and/or Keysakes for additional chances to win a Weekly Prize and/or become a Semi-Finalist.
- Semi-Finalists submit a video stating why they should win a trip to the Super Bowl.
- 5 Finalists will win a trip to the Super Bowl to compete for a chance to sleep in the Super Bowl Sleepover Suite the night before the big game!

## **OFFICIAL RULES:**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void outside the Eligibility Area and where prohibited by law. Subject to all applicable laws and ordinances.

- 1. Sweepstakes Period: Sweepstakes begins at 10:00 AM Eastern Time ("ET") on 24 September 2025 and ends at 11:59 PM ET on 8 December 2025 (the "Sweepstakes Period"). The Sweepstakes Period consists of ten (10) separate weekly entry periods (each a "Weekly Entry Period" or "Entry Period") that begin at 12:00 AM ET each Wednesday and end at 11:59 PM ET each Tuesday during the Sweepstakes Period, except for the last Entry Period which begins at 12:00 AM ET on Wednesday, 26 November 2025 and ends at 11:59 PM ET on Monday, 8 December 2025. Sponsor's computer is the official time keeping device for this Sweepstakes. There is also a Semi-Finalist Period after the Sweepstakes Period where the Semi-Finalists will be required to submit their Videos by 11:59 PM ET on 4 January 2026 in order to have the opportunity to win a Finalist Prize and the Grand Prize.

Winning a prize is contingent upon fulfilling all requirements set forth herein. Sponsor reserves the right to verify the eligibility of Semi-Finalists, Finalists, and winners. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes materials and the terms and conditions of the Official Rules, the English version of the Official Rules shall prevail, govern, and control.
- 3. How to Become a Marriott Bonvoy Sweepstakes Account Holder, Earn Your First Entry into the Current Weekly Entry Period's Random Drawing, your First Entry into Each Subsequent Weekly Entry Period's Random Drawing (if any) and your First Entry into the Semi-Finalist Random Drawing: During the Sweepstakes Period, visit MarriottBonvoyKeysake.com/NFL (the "Website") and complete and submit the online registration form ("Entry") to

register for a Marriott Bonvoy Sweepstakes account ("Sweepstakes Account" or "Account"). By registering for a Sweepstakes Account, you will receive one (1) Entry into the current Weekly Entry Period's random drawing, one (1) Entry into each subsequent Weekly Entry Period's random drawing (if any), and one (1) Entry into the Semi-Finalist random drawing. Limit one (1) Sweepstakes Account per person/email address and limit one (1) Entry per Sweepstakes Account via this method of Entry. Entries must be received by 11:59 PM ET on 8 December 2025 to be included in the final Weekly Entry Period's random drawing and the Semi-Finalist random drawing.

- 4. How Sweepstakes Account Holders Can Receive ("Bonus Entries") into the Current Weekly Entry Period's Random Drawing, each Subsequent Weekly Entry Period's Random Drawing (if any) and the Semi-Finalist Random Drawing:
  - Via the Website Directly: If you are already a Sweepstakes Account holder, each time you log into your Account and upload a photo into one of the available Keysake frames, you will receive one (1) Bonus Entry into each applicable random drawing as described above. Limit one (1) market-specific Keysake upload per participating market. Limit one (1) Bonus Entry per entrant, per market, into each applicable drawing, via this method of Entry.
  - **Via Email:** Submit an email, from a valid email address, including your full name, street address, city, state, zip, date of birth (mm/dd/yyyy) and daytime telephone number to: <a href="mailto:marriottbonvoysweeps@dja.com">marriottbonvoysweeps@dja.com</a> with "Super Bowl Sleepover Sweepstakes Bonus" as the subject. Limit one (1) Bonus Entry per entrant, per Entry Period, into each applicable drawing, via this method of Entry.

Bonus Entries must be received by 11:59 PM ET on 8 December 2025 to be included in the final Weekly Entry Period's random drawing and the Semi-Finalist random drawing. Bonus Entries and Entries will be collectively referred to as "Entries".

5. Entry Requirements, Representations and Warranties (You acknowledge and agree to the following with respect to the Entry you submit): Multiple entrants are not permitted to share the same email address or Sweepstakes Account to submit an Entry. No information regarding Entries, other than as otherwise set forth in these Official Rules, will be disclosed. Any attempt by any entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins or any other methods will void such Entries and that entrant may be disqualified. Receipt of Entries will not be acknowledged. Automated, script, macro or robotic Entries submitted by individuals will be disqualified. Incomplete, corrupted, or untimely entries are void and will be disqualified. Sponsor and its agencies are not responsible for lost, late, incomplete, damaged, stolen or misdirected Entries; lost, interrupted, or unavailable network, server, or other connections; or miscommunications, computer or software malfunctions, telephone transmission problems, technical failures, garbled transmissions, damage to a user's computer equipment (software or hardware), or other errors or malfunctions of any kind, whether human, mechanical, electronic or otherwise. Proof of submission will not be deemed to be proof of receipt by Sponsor. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address associated with the Entry will be deemed to be the entrant or participant. The "authorized account holder" is the natural person assigned to an email address by an Internet access provider, online service provider, Internet service provider, or other organization (which may include an employer) responsible for assigning email addresses for the

domain associated with the submitted address. Potential Semi-Finalists, Finalists, and winners may be required to show proof of being the authorized account holder. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win. Entrant's social media profiles must be keeping with Sponsor's image or Entrant may be disqualified. Normal time rates, data rates and other fees or charges, if any, charged by the Entrant's Internet access, phone or mobile service provider will apply. Any Entry not in compliance with the above and which does not meet the requirements of these Official Rules will be disqualified.

# 6. Random Drawings:

- Weekly Random Drawings: Sixty (60) overall Weekly Prize winners [six (6) per Weekly Entry Period] will be randomly selected on or about each Thursday throughout the Sweepstakes Period, beginning on 2 October 2025, from among all eligible Entries received by 11:59 PM ET on the Tuesday prior (except for the last week, which ends on a Monday). Weekly Entries will be carried forward for any subsequent Weekly Entry Period's drawing(s) and the Semi-Finalist drawing. The odds of winning a Weekly Prize will depend on the total number of eligible Entries received by 11:59 PM on the Tuesday prior (except for the last week, which ends on a Monday) to that Weekly Entry Period's drawing.
- Semi-Finalist Random Drawing: Twenty (20) Entries (potential "Semi-Finalists") will be randomly selected on or about 10 December 2025, from among all eligible Entries received throughout the Sweepstakes Period. The odds of being selected as a Semi-Finalist will depend on the total number of eligible Entries received throughout the Sweepstakes Period.

Random drawings will be conducted by Administrator, an independent judging organization whose decisions are final on all matters relating to the drawings.

- 7. Semi-Finalist Notification: Potential Semi-Finalists will be notified by phone and/or email and will be required to complete and return via email/email link, an Affidavit of Eligibility/Declaration of Eligibility, a Release of Liability, a background check authorization, and, if legally permissible, a Publicity Release within forty-eight (48) hours of Administrator's attempted delivery of same. Noncompliance within the specified time period or return of any Semi-Finalist notification as undeliverable, or declining for any reason, will result in disqualification without further notice and an alternate Semi-Finalist may be selected in a random drawing from among all remaining eligible Entries received, time permitting. Potential Semi-Finalists are subject to verification by Sponsor and/or Administrator, whose decisions are final and BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. The "Released Parties" (as defined below) shall have no liability for any Semi-Finalist notification that is lost, intercepted or not received by a potential Semi-Finalist for any reason. All Semi-Finalists must become a Marriott Bonvoy member prior to prize award if they are not a member already. There is no cost or fee associated with becoming a Marriott Bonvoy member. - 8. Finalist Round/Video Submission: Once verified, the twenty (20) Semi-Finalists will receive a link from the Administrator, via email, where they can upload a video (up to 30 seconds in length) explaining why they are the NFL fan most deserving of a trip to the Super Bowl ("Video Submission" or "Video"). If the Video exceeds 30 seconds in length, only the first 30 seconds of the Video will be judged. Submission of a Video constitutes Semi-Finalist's agreement to these Official Rules. Video Submissions must be received by 11:59 PM ET on 4 January 2026, or Semi-Finalist will not move on to the Finalist Round. Video Submission must meet all the Video Submission Guidelines listed below to be eligible. There is a limit of one (1) Video Submission per Semi-Finalist. Any Video Submission that violates these Official Rules or is otherwise objectionable (as determined solely by Sponsor), will not be considered and will be disqualified.
- 9. Finalist Determination/Video Judging: Video Submissions will be judged by the Administrator (at their offices in Melville, NY USA), along with the Sponsor, to determine five (5) Finalists based on the following criteria: Originality and Creativity (35%); Storytelling/Persuasiveness (25%); Passion for football/Super Bowl (20%); Video Quality/Presentation (10%); Overall Impact (10%). In the event of a tie, tied Videos will be re-judged based solely on

Originality and Creativity on a scale of 1-100 points. Administrator reserves the right to determine fewer than five (5) Video Submissions as Finalists if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Video Submissions and/or if fewer than five (5) potential Finalist Prize winners return any paperwork requested within the required timeframe, as outlined below. Decisions of Administrator and Sponsor are final and binding with respect to all matters relating to this Sweepstakes.

### **VIDEO SUBMISSION GUIDELINES:**

- Video must be entrant's own original work and must not have won a previous prize or award.
- Video must not (and entrants represent and warrant that it will not), violate or infringe any third-party copyright, trademark, trade dress, or other proprietary right of any entity or person (living or deceased), including but not limited to rights of privacy, publicity or portrayal in a false light.
- Video should not include content with the potential to result in any injury or bodily harm to the entrant or any third party.
- Video must not reference any commercial/corporate advertising, including but not limited to corporate logos, brand names (other than Sponsor's and NFL's), slogans, political, or religious statements, or be otherwise objectionable, as determined in Sponsor's/Administrator's sole discretion.
- Entry must not include any commercial solicitation or promotional materials, websites, contact information or personally-identifiable information (e.g., first or last name, address, phone number, place of work, email address, etc.).
- Sponsor has in its sole discretion, the option (but not the obligation) to blur or black-out any imagery that Sponsor deems objectionable.
- Any Entry deemed inappropriate or unsuitable, in Sponsor's/Administrator's sole discretion, will be disqualified and may be deleted.
- Entry must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age.
- Entry cannot defame, misrepresent or contain disparaging remarks about Sponsor, the Released Parties, or their respective products and services, or other people, products or companies.
- Entry must not contain content that is false, inaccurate or misleading.
- Entry must not contain statements or images relating to the armed forces of the United States; local, state or federal governments; state flags, emblems, seals, coat of arms, crests or insignias.
- Entry must not include references to any activity that Sponsor/Administrator deem to be, in their sole discretion, lewd or indecent, including but not limited to, scenarios portraying sexually explicit activity, violence or other inappropriate behavior.
- Entry should be suitable for viewing by the general public and airing on broadcast television (e.g., no vulgar language, nudity, or other similar content).
- If an Entry includes the image or likeness of anyone other than the entrant, entrant represents and warrants that entrant has obtained permission from each such individual, that entrant agrees to provide written copies of such permission to Sponsor upon request, unless such individual is entrant's child or charge.
- 10. Background Checks: Semi-Finalists understand and agree that, as a condition of being considered a Semi-Finalist, they (and their potential travel companion should they become a Finalist) may be subject to a background check, at the sole discretion of Sponsor. In such event, an alternate potential Semi-Finalist will be selected. In the event a background check indicates that a potential travel companion: (a) has been charged with or convicted of a felony; (b) has been charged with or convicted of a misdemeanor involving moral turpitude or other conduct that Sponsor in its discretion determines may reflect unfavorably on the Sweepstakes or Sponsor; (c) has been personally involved in interaction deemed by the Sponsor as negative with government/state child & family services/protection

agencies; or (d) has not adhered to applicable requirements set forth in these Official Rules, such travel companion will not be permitted to accompany Finalist on trip (should they become a Finalist) and Finalist may have the opportunity to select another travel companion in their place, time permitting.

- 11. Grand Prize Competition: The five (5) Finalists attending Super Bowl LX in Santa Clara, California will take part in a Sponsor-specified event, activity, or challenge (the "Grand Prize Competition"), along with their travel companions if they bring one (subject to final determination) during Super Bowl weekend, for a chance to win the Grand Prize. To remain eligible, Finalists and their travel companions must participate in the Grand Prize Competition at the time and place specified by Sponsor. The format and rules of the Grand Prize Competition will be set by Sponsor, and Sponsor's decisions, including winner determination, are final. If a Finalist and/or their travel companion is unable or unwilling to attend or participate in the Grand Prize Competition as directed, that Finalist will forfeit his/her/their opportunity to compete for the Grand Prize, and Sponsor will proceed with the Grand Prize Competition with the remaining eligible Finalists. All decisions of Sponsor regarding the conduct of the Grand Prize Competition, including but not limited to judging criteria, winner determination, and any tie-breaking procedures, shall be final and binding in all respects and Finalists and their travel companions agree to same.

Prizes and Approximate Retail Values ("ARVs") in USD: One (1) Grand Prize: Overnight (one night; double occupancy) accommodations for Grand Prize winner and their travel companion in the Super Bowl Suite at Levi's Stadium in Santa Clara, CA USA, the night prior to the Event (there is no ARV associated with the Grand Prize); Five (5) Finalist Prizes: A three (3)-day/two (2)-night trip beginning 7 February 2026 through 9 February 2026, for Finalist and one (1) travel companion to attend Super Bowl LX in Santa Clara, California USA ("Event"). Each Finalist Prize includes roundtrip economy air transportation from major airport nearest winner's home (in Sponsor's sole discretion) to San Francisco, CA USA, two (2) night's hotel accommodations (one standard room; double occupancy), a pair of Event tickets and roundtrip ground transportation to/from Levi's stadium (ARV USD \$10,400 each); Twenty (20) Semi-Finalist Prizes: A USD \$300 Marriott digital GiftCard. Gift Card terms and conditions apply and can be found here (https://gifts.marriott.com/terms.html). Sixty (60) Weekly Prizes [six (6) per week]: A USD \$50 digital NFL Shop eGift card. Gift card terms and conditions apply and can be found here (https://www.nflshop.com/gift-cards/gc-1). Physical gift card may be shipped if NFL Shop gift card winner resides outside the U.S. The total ARV of all prizes is USD \$61,000. Actual retail value of the Finalist Prizes may vary. Prize Restrictions: Limit one (1) Weekly Prize and one (1) Semi-Finalist Prize and one (1) Finalist Prize per person/household. No more than the stated number of Prizes will be awarded. All Prizes will be awarded provided a sufficient number of eligible Entries are received for each drawing (and all Video Submissions are included for the Finalist judging) and all paperwork is completed and received within the given timeframe. Finalist's travel companion (or Finalist as parent/legal guardian of travel companion if they are a minor in their jurisdiction of primary residence and winner's child/charge) will be required to execute a release of liability prior to travel. If a Finalist elects to travel with no travel companion, no additional compensation will be awarded for the travel companion portion of prize. Prize winners and travel
